ELECTRONIC FILING INFORMATION

W-2 FORMS - MUST BE FILED ELECTRONICALLY OR ON PAPER

Mag-Media filing will no longer be accepted by the Social Security Administration (SSA) as of February 28, 2006.

1099 FORMS MUST BE FILED ELECTRONICALLY OR ON PAPER AS OF 12/1/08

The change in the electronic filing requirements generally affects information returns relating to interest and dividend payments (Forms 1099INT, DIV, OID, and PATR) and broker and barter exchange transactions (Form 1099B). You are required to file such information returns electronically only if you are required to file 250 or more returns.

OTHER INFORMATION RETURNS

If you are required to file 250 or more returns on Form 1098, 1099A, 1099G, 1099MISC, 1099R, 1099S, 5498 or W-2G you are required to file electronically. For determining the number of returns you are required to file "count each type of form separately", for example, if you must file 300 Form 1098 and 100 1099MISC, you are not required to file Form 1099MISC electronically, but you must file Form 1098 electronically.

The due dates for Electronic Filing are the same as for Paper Document Reporting.
